**ADMISSION NOTICE FOR B. ARCH. FOR ACADEMIC YEAR 2018-19**

This notice is being issued for Online Registration & uploading of documents, Documents Verification and Application Form Confirmation at Facilitation Centers (FC) by candidates aspiring for admissions to First Year of Five Year Duration Full Time Architecture program (B. Arch.) in the Government, Government Aided, University Managed Institutes, University Managed Departments and Unaided private professional educational institutes for the Academic Year 2018-19 in the Maharashtra State.

<b>Eligibility Criteria for various types of candidature for Admission:</b>	
<b>Maharashtra State Candidates, Jammu &amp; Kashmir Migrant Candidates and All India Candidates</b>	<b>NRI/OCI/PIO, Children of Indian workers in Gulf Countries (CIWGC), Foreign National (FN) Candidates</b>
(i) The candidate should be an Indian National; (ii) Passed HSC or its equivalent with Mathematics and obtained at least 50% marks in aggregate (at least 45% marks in aggregate in case of candidates of Backward class categories and Persons with Disability belonging to Maharashtra state only) or as declared by the Appropriate Authority, from time to time; <p style="text-align: center;"><b>Or</b></p> (ii) Passed (10+3) Full time Diploma examination recognized by All India Council for Technical Education or Central or State Government or its equivalent examination and obtained at least 50% marks in aggregate (at least 45% marks in aggregate in case of candidates of Backward class categories and Persons with Disability belonging to Maharashtra state only) with Mathematics as compulsory subject or as declared by the Appropriate Authority, from time to time;  (iii) The Candidate should have obtained qualifying marks in NATA or obtained Non Zero Positive Score in JEE (Main) Paper II;	(i) The Candidate should have passed the HSC or its equivalent examination with Mathematics and obtained at least 50% marks in aggregate or as declared by the Appropriate Authority, from time to time; <p style="text-align: center;"><b>Or</b></p> (i) Candidate should have passed Full Time Diploma (10+3) examination recognized by All India Council for Technical Education or Central or State Government or its equivalent examination and obtained at least 50% marks in aggregate with Mathematics as compulsory subject or as declared by the Appropriate Authority, from time to time;  (ii) The Candidate should have obtained qualifying marks in NATA as declared by appropriate authority from time to time or obtained Non Zero Positive Score in JEE Main Paper II.  (iii) Any other criterion declared from time to time by the appropriate authority as defined under the Act.

**Online Registration for Admission: -**

- 1.1 The candidates should apply online on [www.mahacet.org/arch2018](http://www.mahacet.org/arch2018) as per schedule.
- 1.2 Candidates are required to pay fees as given below only by **Credit Card/ Debit Card/ Net Banking etc.** through Online mode. Fees paid is non-refundable. (No other mode of payment shall be permitted.)

<b>Important Note: -</b> <ol style="list-style-type: none"> <li><b>All types of candidates</b> aspiring for admission under CAP seats shall register, get Documents Verified &amp; Application Form confirmed at any designated Facilitation Center. Such eligible registered candidates shall be considered for CAP Merit and admission through CAP.</li> <li><b>In case of NRI/OCI/PIO, CIWGC, FN Candidates, after registration &amp; confirmation of their application at FC shall approach directly to the Institute for admission where such quota is granted by the appropriate authority.</b> However, CET Cell may publish the list of such registered &amp; eligible candidates separately on website.</li> <li>Candidate shall carry printed copy of Application Form, Original documents and one set of Xerox copies of the required documents. FC shall verify all documents from Original and put <b>FC stamp with date &amp; Signature on Xerox copies</b> and return original and verified documents along with Receipt-cum-Acknowledgement of application form. (Candidate shall submit FC stamped &amp; verified set of documents to ARC for re-verification after the allotment and then to the Institute at the time of reporting)</li> <li>The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is <b>mandatory</b> to get registered, documents verified and confirmation of application at facilitation centers. Such candidates must apply separately to Institutes for admissions to seats other than CAP Seats. Merit of such candidates shall be prepared by the Institute at the institute level.</li> <li>*Facility of Online Registration &amp; Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till 14<sup>th</sup> August 2018 up to 5.00 PM at FC. <b>Applications registered, verified &amp; confirmed at FC after Last Date i.e. 20<sup>th</sup> June 2018 shall be considered only for Other than CAP Seats.</b></li> </ol>			

#### **Important Instructions for candidate:**

- The candidates are required to produce the **documents in original** for verification and Confirmation of Application Form at FC. It is mandatory on the candidate's part to produce all original documents in support of the claim made by the candidate in the application form. Candidates are advised to keep the necessary documents ready at the time of Documents verification stage as per the notified schedule.
- If candidates fail to confirm online filled application form at FC, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission for both CAP as well as Non-CAP process.
- The candidates belonging to SC, VJ/DT (NT (A), NT (B), NT(C), NT (D), OBC and SBC categories shall produce "Caste Validity Certificate" and ST category shall submit "Tribe Validity Certificate". All Backward Class candidates excluding SC & ST shall produce **Non Creamy Layer** certificate **valid up**

**to 31<sup>st</sup> March 2019.** If such candidates fail to produce the Caste/Tribe validity and Non Creamy Layer certificate at the time of verification at FC, then such candidates will be treated as GENERAL category candidates for CAP Admissions.

4. Candidates who have registered as a reserved category candidate but unable to produce Caste/Tribe certificate for reservation claim during documents verification phase shall have to pay difference of fees of ₹ 200/- at the FC through online mode only.
5. **For J & K Migrant candidates:** - Application received after the last date from candidates belonging to J & K Migrant candidates will be summarily rejected and no correspondence will be entertained in this regard. Such Candidates will get the **Receipt-cum-Acknowledgement** through their login after confirmation of application form by FC.
6. NRI/PIO/OCI/CIWGC/FN candidates will get the Receipt-cum-Acknowledgement through their login after confirmation of application form by FC.
7. Once the candidate confirms his/her Option form online through his/her Login for the respective admission rounds, Candidate will not be allowed to change/cancel the option/preference submitted under any circumstances.
8. A Candidate who has been allotted a seat shall download the "Provisional Seat Allotment Letter"
9. The Seat Acceptance Fee shall be Rs. 1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first reporting only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fees is to be paid at ARC through ONLINE MODE only.
10. Seat will be confirmed by the Admission Reporting Centre (ARC) after verification of the original documents and ensuring that the Candidate meets all the eligibility norms. The centre in-charge shall issue the Online Receipt of seat acceptance to the candidate. Candidate shall produce the set of copies of uploaded documents verified and stamped by FC to ARC. After verification ARC shall put **ARC stamp with date & Signature on all copies of documents of this set** and return the same set of documents to the candidate along with Receipt -cum-Acknowledgement of application form.

#### **General Notes:**

1. Candidate can avail the IT facilities which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, confirmation of Application form.
2. List of FCs is available on website. All FC's shall remain open on all days including holidays and Sundays during the schedule between 10.30 a.m. to 5.30 p.m.
3. Eligibility, Rules & regulations for admission shall be made available on the website.
4. The schedule displayed above is provisional and may change under unavoidable circumstances.
